Benefits enrollment

- Within 31 days of:
 - Hire date; or
 - Special eligibility situation, such as marriage, childbirth, adoption or loss of other coverage.
- Your employer will initiate the initial enrollment process.
- You will need to provide a valid email address to your employer, then make your elections online by following the instructions in the email you receive from PEBA.
 - View the <u>Insurance Enrollment Guide for New Hires</u> flyer.
- Your benefits administrator can also assist you.
- You must provide Social Security numbers and supporting documentation to add eligible dependents to coverage.
- Transfers must coordinate their insurance enrollment with their new employer; you cannot make changes to existing coverage.

Open enrollment period

- October 1-31 each year.
- Make coverage changes for following year.
- · Review your current coverage.
- $\bullet\,$ Review your life insurance beneficiaries and make any updates.
 - Provide phone numbers and email addresses for your beneficiaries.
- If you are satisfied with your current elections, the only thing you need to do is re-enroll in MoneyPlus flexible spending accounts.
- Dental changes can be made during open enrollment only in odd-numbered years.
- Log in to MyBenefits at <u>mybenefits.sc.gov</u> to make open enrollment changes.
