Use the worksheet below to calculate the amount you may wish to contribute to a Medical Spending Account (MSA) or a Dependent Care Spending Account (DCSA).

Be sure to include the amounts you listed on Pages 4, 6 and 8 of the 2023 *Insurance Summary* in the worksheet. Be conservative in your planning. Remember that any unclaimed funds cannot be returned to you. You can, however, carry over up to \$610 of unused MSA funds into the 2024 plan year. You cannot carry over DCSA funds, and you cannot transfer funds between flexible spending accounts. Refer to Page 12 of the 2023 *Insurance Summary* for annual contribution limits.
