- Review and update beneficiary designations.
- Estimate benefit amount.1
- Update address and contact information.
- Calculate service purchase cost estimate and submit service purchase request.
- · Apply for service retirement.
- Refer to <u>Manage your Retirement Account with</u> <u>Member Access</u> flyer.

State ORP participants

- Link to State ORP service provider's website.
- View and update PEBA active member incidental death beneficiaries.
- Must designate beneficiaries for your State ORP account balance with your service provider.
- Update address and contact information with PEBA.
- Must update separately with service provider.
- Receive messages regarding annual State ORP open enrollment (January 1–March 1).
 Change State ORP service provider or make an irrevocable election to switch to SCRS, if eligible.

Benefit consultations

- Appointments for one-hour phone and video consultations.
 - Will receive the same service regardless of the type of consultation you choose
 Can book appointments up to 21 days in advance.

 - · Visit our benefits consultation page to select a date and time.
- · Walk-in consultations at 202 Arbor Lake Drive
 - In-person visits can have longer wait times.
 Recommend that you arrive by 4 p.m.
